CITY ORDINANCE NO. 19-004

AN ORDINANCE CREATING THE LEGISLATIVE BACKSTOPPING COMMITTEE OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF HIMAMAYLAN

Be it ordained by the Sangguniang Panlungsod of Himamaylan City that:

Section 1. Title - This ordinance shall be known as the "An Ordinance Creating the Legislative Backstopping Committee."

Section 2. Composition - The Legislative Backstopping Committee shall be composed of the following:

1. Chairperson : Vice Mayor
2. Vice Chairperson : Secretary to the Sangguniang Panlungsod
3. Members : Four (4) Staff from the Office of the Vice Mayor and the Office of the Sangguniang Panlungsod

Section 3. Duties and Functions:

1. Set up a management information system for legislative action or decision.
2. Provide assistance in the preparation of the local legislative agenda.
3. Conduct research in aid of local legislation
4. Act as liaison between the local government executive departments and the Sangguniang Panlungsod.
5. Assist in the review of Ordinances and Resolutions of Sangguniang Barangays;
6. Take charge of the tracking and analysis of enacted Ordinances and Resolutions to:
 - a. Determine whether an enacted measure is actually implemented or enforced through inquiry with the Office of the City Mayor or Department/Office responsible for the implementation or enforcement of the same;
 - b. Determine whether the target sector of the population is aware of and familiar with the said Ordinance or Resolution;
 - c. Evaluate the effectiveness of an implemented or enforced Ordinance or Resolution;

OF THE SANGGUNIANG PANLUNGSOD SESSION
DATED JULY 22, 2019

7. Translate into the local language salient points of legislative measures; and
8. Perform other local legislative-related functions as may be assigned by the Vice Mayor, such as legislative staff development, agenda preparation for sessions, technical assistance during public hearing and committee meetings.

Section 4. Funding - A regular budget to be taken from the General Fund shall be appropriated every calendar year to defray the Committee's operating expenses F Y 2020. For operations in FY 2019 funding shall be taken from the Office of the Sangguniang Panlungsod.

Section 5. Separability Clause - If for any reason, any provision, section or part of this Ordinance is declared not valid by the Court of competent jurisdiction or suspended or revoked by the Sangguniang Panlungsod; such judgement shall not affect or impair the remaining provisions, sections or parts thereof which shall remain or continue to be in full force and effect.


Section 6. Effectivity - This ordinance shall take effect after complying with the provision of Section 59(b) of the 1991 Local Government Code.


